A) Course Objectives

D) Teaching Learning Process:

1. The students are encouraged to read the original texts and the teacher often participates in the reading process. Thereby the teacher engages in active, rather than passive, pedagogy.
2. It is important that the classroom sessions, initiated either by the student or the teacher, would encourage teamwork and draw students towards learning, yet there are other means available now which add to that. The use of digital/ICT generated techniques (audio-visual aids).

E) Assessment Methods:

1. Class assignments/term papers, theme(s) of which are chosen following teacher student discussion, is one of the ways of assessing the subject and writing skill of the students.
2. Tutorial discussion oral presentations and viva-voce, short individual/team led field studies/projects and seminars/workshops are other modes of assessment. These are included in the Internal Assessment (IA) system.
3. Mid-semester examination is another mode of assessment. Here again, the topic(s) on which the students are to be examined are chosen through teacher-student consultation. Mid-semester examination tests the students on the grasp of the topic(s) in particular and the discipline in general.
4. The end-semester examination is conducted by the university and the student is tested and evaluated on the basis of the entire paper (syllabus). S/he is expected to have a full knowledge of the paper and prescribed readings.

- The linkage will be valid for the period of **five years** starting from the date of signing this agreement and be renewed for the further period of years through mutual understanding and consent.

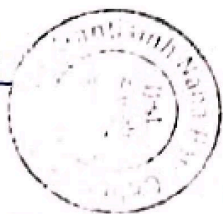

CL. 2 PREAMBLE

WHEREAS Hindustani Prachar Sabha is a Trust working in the field of promotion of Hindi and Urdu languages in the public interest.

AND WHEREAS MVPKM (*Malati Vasantdada Patil Kanya Mahavidyalaya*) approached Hindustani Prachar Sabha for the purpose of starting a new project for promotion of Hindi and Urdu languages in the campus of MVPKM .

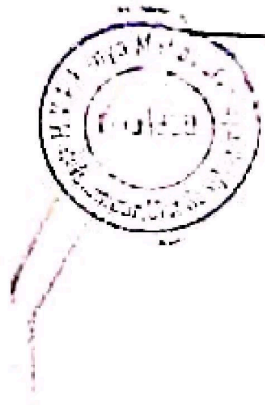
AND WHEREAS both the parties to the agreement are well known in their fields and working in the interest of the public at large and for charitable purposes, are eager to promote Hindi and some other languages with the help of each other.

AND WHEREAS both the parties have decided to enter into an agreement to promote Hindi and Urdu the following terms and conditions.



NOW THIS AGREEMENT WITNESSETH AS FOLLOWS.

1. That both the parties shall act with the intention to promote Hindi and Urdu languages. The project shall start by making available literature in various forms like books, CDs, presentations, lectures, etc. to students, patriotic and prospective readers and public at large. Promotion of this literature is social / educational need based and will enable students also to become more aware of the rich heritage and culture of India.
2. That the project shall run under the name and style of MVPKM and Hindustani Prachar Sabha's Hindi and Urdu Promotional Project" and the centre will be named "MVPKM and HPS Library" and will include a reading room.
3. That the period of this agreement shall in the first instance be for 3 years commencing from 1st December, 2016. After 3 years this agreement shall be extended for such periods of time as may be mutually agreed upon by both the parties.
4. That MVPKM shall provide premises at its center free of cost to the Sabha for storing books in Hindi, Urdu, Marathi, Gujarati and English.
5. The MVPKM shall also make, at its own cost, necessary furniture to start a library in the premises provided by MVPKM at Islampur, Tal. Walwa, Dist. Sangli. If necessary, Hindustani Prachar Sabha will contribute towards procurement of furniture a sum not exceeding Rs.50,000/-.
6. That in furtherance of the project, Hindustani Prachar Sabha shall at its own cost provide for the library to be set up books, magazines, periodicals, etc., in hard copy or as CDs, or in any other form, etc., in Hindi, English, Marathi, Gujarati and Urdu on various subjects like Arts, Science, Political Science, Politics, Indian Culture, Travel and Tourism, etc.



The total value of the books and other materials mentioned above proded by HPS for the Library would be Rs. 1.50 Lacs.


7. The furniture, books, magazines, periodicals, CDs, etc., supplied by Hindustani Prachar Sabha to the proposed Library shall continue to be the property of Hindustani Prachar Sabha. 11. That all the necessary statutory dues shall be paid by Beneficials.
12. That either party may terminate this agreement by giving one month's notice in writing to the other party.
13. That, neither party shall act in any manner prejudicial to the interests of the other party.
14. That, Intellectual Property Rights, if any, in any book, magazine, pamphlet or study material published or produced by the Hindustani Prachar Sabha shall vest exclusively in the name of Hindustani Prachar Sabha.





CL. 2 PREAMBLE

CL.5 EFFECTIVVE DATE, DURATION, TERMINATION OF THE AGREEMENT.

CL.5.1 The Memorandum of understanding will remain in force for a period of **Seven** years, calculated from the date of first meeting Management Committee, unless the duration of the Action is modified according to the provision.

CL.5.2 The agreement shall terminate on the expiry of the period, as in clause 11.1 unless extended by both the parties.

CL.5.3 During the tenure of the agreement, parties hereto can terminate the agreement either for breach of any terms and conditions of this agreement or otherwise by giving a one month notice in writing to the defaulting party. Failure of either party to terminate the agreement on account of breach or default by the other shall not constitute waiver of that party's right to terminate this agreement.

CL.5.4 In the event of termination of the agreement vide clause 11.3 the right and obligation of the parties, thereof shall be settled by mutual discussion.

CL.6 NOTICE

CL.6.1 All notice and other communication required to be served on the PARTY under the terms of this agreement shall be considered to be duly served if the same shall have been delivered to, left with or posted by registered mail to the Party at its last known address of **Research Knowledge and Activity**. Similarly, any notice to be given to **Satara Itihas Sanshodan Mandal, Satara** shall be considered as duly served if the same shall have been delivered to, left with or posted by registered mail to the **Satara Itihas Sanshodan Mandal, Satara** at its registered address in Satara.

CL.7 AMENDMENTS TO THE AGREEMENT

CL.7.1 No amendment or modification of these agreements shall be valid unless the same is made in writing both the parties and their authorized representatives and specifically stating the same to be an amendment of this agreement. The modifications / Changes shall be effective from the date on which they are made / executed, unless otherwise agreed to.

CL. 8 ASSIGNMENT OF THE AGREEMENT

CL.8.1 The rights and liabilities arising to any party to this agreement shall not be assigned except with written consent of the other party and subject to such terms and conditions as may mutually agree upon.

CL.9 ARBITRATION

CL.9.1 Except as hereinbefore provided, any dispute arising out of this Agreement, the same shall be referred to the arbitration of arbitrators, one to be appointed by each party to the dispute, and in case of difference of opinion between them to an umpire appointed by the said two arbitrators before entering on the reference, and decision of such arbitrators or umpire and the arbitration proceedings shall take under the Indian Arbitration Act, 1996.

CL.10 FEE STRUCTURE

CL.10.1 The fees of Major Training Program, Seminar, Conference, Workshop etc. shall be finalized by Co-operation.
